**EVENT REGISTRATION DATES:**

Opening Date	FEBRUARY 13	Entries may not be postmarked BEFORE this date
Closing Date	MARCH 13	Entries postmarked AFTER this day will incur \$20 late fee.

First 80 COMPLETE entries accepted based upon postmarked date.

A wait list will be created and potential entrants will be contacted as space becomes available.

**LEVELS OFFERED:**

<b>MODIFIED NOVICE</b>	2018 USEF Novice Test A; jump height 2'11" Show Jumping, Beginner Novice XC course, water on XC
<b>BEGINNER NOVICE</b>	2018 USEF Beginner Novice Test A; jump height 2'7", water on XC
<b>STARTER</b>	2015 USDF Intro Test C (walk, trot, canter); jump height 2'3" , water option on XC
<b>AMOEBBA</b>	2015 USDF Intro Test B (walk & trot); jump height 18"

All dressage tests to be ridden on a small grass arena.

**EVENT TO BE HELD IN ACCORDANCE WITH 2015 USEF RULES FOR EVENTING EXCEPT FOR:**

Amoeba only: Entries allowed use of any bit, martingale, anti-grazing rein, etc., as needed for safety.

Amoeba only: Coaches are welcome on stadium courses and XC courses with riders.

All Divisions: NO optimum time requirement for stadium or XC = NO time faults added to score.

All Divisions: Medical armbands/bracelets required at all times while mounted, ALL phases.

If a rider is eliminated in any phase of competition, rider MAY request permission from the TD / Organizer to continue on as a schooling opportunity. Permission will be granted at the discretion of the TD / Organizer, and only if time permits. If permission is granted, rider will be allowed ONE stop in Stadium or on XC before being asked to leave course. Decisions regarding safety are the sole discretion of the TD for safety purposes and those decisions are final.

**Tentative Schedule & Ride Times:**

Ride times will be posted on STARTBOX, MTPC Facebook Page & <https://middletennessee.ponyclub.org/> no later than Wednesday prior to the event.

Stadium and XC courses will be open for walking at 4:00 pm Friday, April 6, 2018

Numbers and course maps may be picked up at the Show Office at PWP starting at 6:30 am day of show.

Modified Novice dressage will begin at 7:30 am, followed by Beginner Novice, Starter and Amoeba.

Stadium will commence following a short lunch break.

Riders will proceed directly to XC from Stadium.

**Awards:**

6 awards per division. Divisions may be split as needed.

**Other:**

Informal attire, but helmets, appropriate footwear and medical armbands/bracelets required for all rides. XC vests required for all XC rides.

NO double entries – for pony safety, they may not be shared at this event.

NO shavings available on site – you must bring your own if you are stabling.

Concessions will be available on grounds.

Dogs must be leashed.
